

Facts About Essential Services During the Covid-19 Outbreak

In Minnesota, Governor Walz has issued Peacetime Emergency Orders that provide some assistance and safeguards for families whose incomes have been reduced because of the COVID-19 outbreak.

Financial

If you are having trouble paying your bills, it is your responsibility to contact each company and ask for assistance.

- Unemployment
 - o From March 16, 2020 through the end of the peacetime emergency, the typical waiting week for unemployment has been suspended. Unemployment is available to individuals who are unable to work due to circumstances that were no fault of their own, including reasons related to COVID-19.

- Many telephone, internet and cell providers have signed the <u>"Keep America Connected</u> <u>Pledge"</u> and are responding by not disconnecting services, and/or making special payment plans available. In addition, many providers are opening public hotspots and offering free wifi for students and low-income families.
 - <u>Comcast</u> is opening its Xfinity WiFi Network nationally for free, offering unlimited data for free, connecting low-income families to free internet learning. <u>https://corporate.comcast.com/covid-19</u>
 - <u>AT&T</u> is suspending the termination of wireless, home phone or broadband service when customers can't pay their bills because of coronavirus disruptions. - <u>T-Mobile</u> is providing unlimited data to all current customers who have plans with data for the next 60 days. It will also provide additional data to mobile hotspot users. <u>https://www.t-mobile.com/news/t-mobile-update-on-covid-19-response</u>
- <u>Arvig</u> New customers in homes with K-12 or college students can sign up for free internet, including Wi-Fi if needed, with Arvig. The service will be free until the school year resumes. <u>https://www.arvigbusiness.com/news/covid19response/</u>
- <u>Charter Spectrum</u> broadband subscription can get free broadband and Wi-Fi for 60 days with the installation fees waived. - Housing
 - From March 24, 2020 through the end of the peacetime emergency, landlords and mortgage holders cannot remove people from properties. Willfully violating this order will lead to a misdemeanor charge and up to \$1000.00 fine.

<u>Childcare</u>

- School districts have been asked to provide childcare to elementary age children whose parents are
 "front line" or "essential" employees. This includes many health care workers, pharmacists, grocery
 store workers, delivery people, and others. Information can be found here.

- In addition, Governor Walz announced that Minnesota will partner with the YMCA to provide care for the school-age children of emergency workers in Minnesota. Thirty-eight locations across Minnesota will open to provide access to distance learning and care to children in kindergarten through sixth grade, coordinating with school districts.
- A full list of locations is available at <u>ymcamn.org/mnchildcare</u>. The cost is \$40 per day and locations will coordinate with school districts on food drop-off sites. Registration is open and accessible at <u>ymcamn.org/mnchildcare</u> or 612-230-9622
- Childcare providers that serve younger children have also been instructed to continue to remain open for frontline and essential workers, and legislation is currently proposed to help these providers maintain economic viability during this time.

Health Insurance

- Due to the disruption that COVID-19 has caused in the lives of Minnesota families, the MN Department of Human Services has currently ceased renewal and closure notices for Minnesotans on CHIP, Medical Assistance, and MinnesotaCare. Enrollment in the programs continues during the COVID-19 pandemic.
- Some clinic systems have moved toward virtual visits, including e-visits, televisits and video visits. Some clinic systems are moving toward well child only clinics for the continuation of needed vaccinations and other well child related medical matters. Recent insurance changes in response to COVID-19 provide coverage for these visits.
- Copays, deductibles and other expenses related to COVID-19 have, for most plans, been eliminated.
- MNSure: A 30-day <u>special enrollment period</u> for MNSure has been introduced for those who qualify. This allows those who qualify, to to sign up for health insurance coverage through MNsure, beginning Monday, March 23, through Tuesday, April 21.
